Marriage and birth certificates without parental information and documents issued more than six months ago are not accepted (with the exception of the Declaration of Marriage for the Province of Quebec):

For the spouse/partner of Swiss nationality:

- ☐ Copy of passport or driver's license after name change following marriage (if applicable)

For the foreign spouse/partner:

- ☐ original birth certificate with parentage (if the spouse was born in another country, follow the instructions under "additional information")
- ☐ if divorced: divorce certificate and first page of the court order/decreed (original documents)
- ☐ if widowed: death certificate (original document)
- ☐ copy of passport or other valid identity document

Certain documents may no longer be required if the person is already registered in the Swiss civil status register.

Translation

Documents that are not in a Swiss language or in English must be translated in one of these languages.

Photocopies of original documents are not accepted. Additional documents may be required, if necessary.

An [Affidavit](#) represents a solemn declaration concerning the civil status prior to marriage. This must be certified by a notary (public) only. Documents sworn by a commissioner of oaths or otherwise will not be accepted by the authorities in Switzerland.

If the spouse was born in another country, please check with the responsible Swiss representation in that country to find out which documents to submit for legalization. Foreign civil status documents must be legalized by the Swiss diplomatic or consular representation in those countries and the requirements differ from country to country.
