# Welcome to Switzerland Schengen Visitor Visa

# Appointment:

**Prior to** submitting your application with this Consulate, <u>please make an appointment</u> with the company VFS via the internet address <u>www.vfsglobal.ch/Switzerland/Hongkong</u> or by phone (+852) 3018 3030. The appointment is free of charge.

<u>The main destination of your visit must be Switzerland</u>, but the visa issued will permit you to travel to all Schengen countries (unless stated otherwise on the visa).

<u>After having secured an appointment kindly submit your application in person and on time</u> at the Consulate General of Switzerland in Hong Kong.

The following documents are required and should be submitted in the following order:

#### □ 1 Schengen visa application form

duly completed and signed by applicant on page 4

#### Minors (below age 18):

- Both parents must sign the application and add a copy of their passport
- Letter of consent of parent(s) if children are travelling unaccompanied or with one parent only
- Birth certificate, name and address of school, if applicable: child custody court documents

# **2** identical passport photos (35x45 mm)

in colour, made within last 6 months, bright and plain background, not stapled and not damaged

#### **Current valid passport**

- must be valid for more than 3 months beyond your return date to Hong Kong
- passport should not be damaged and have at least 2 blank visa pages left

# □ Previous passport(s)

# **Copies of the following passport pages that contain:**

- full name, photo, signature, expiration date of your passport and family information - previous Schengen visa(s)
- Hong Kong visa (must be valid <u>at least 2 months</u> beyond your return date to Hong Kong)

# □ Hong Kong ID card and 1 copy thereof

Confirmed flight reservation(s) to the Schengen area including return to Hong Kong
If you visit Switzerland <u>and</u> other Schengen countries, please submit also flight, car or rail reservations made for traveling within the Schengen area (complete Schengen itinerary)

#### Invitation letter from host in Switzerland or other Schengen country

- either faxed (3509 5050) or scanned & emailed to Consulate General (hongkong.visa@eda.admin.ch)
- invitation letter should be dated and signed by the host and contain detailed contact information of the host (phone, email) and information on the nature and history of the relationship between host and applicant as well as the purpose of the visit of the applicant
- passport copy of the host and Swiss residence permit (for foreigners)

# □ Travel health insurance including policy with schedule of benefits should indicate:

- full name of applicant
- destination area (must be valid for ALL Schengen countries, recommendation: worldwide)
- period of insurance (must be valid for the duration of the requested visa)
- benefits must cover the following benefits:
  - Repatriation for medical reasons
  - Emergency medical expenses
  - Medical emergency treatment at a hospital
  - > Death (including repatriation after death occurred)
- minimum coverage of EUR 30,000.- for the above mentioned benefits

#### □ Evidence of sufficient financial resources

- Personal bank statements of last three (3) months stating your full name and address (credit card statements or deposits are **<u>not</u>** evidence of sufficient financial resources)

If you do not have the financial means to cover the costs of your trip you will be handed a declaration of guarantee, which you will need to send to Switzerland to your host for financial verification. Such applications usually take more than 1 week to process and should be filed more than 1 month prior to your intended departure date.

#### **Proof of employment or enrolment (students)**

- Leave letter from current employer (stating your position, salary) or school (confirming your enrolment) also stating the purpose as well as duration of your trip including the date of returning to work or school
- Current employment contract and business card

Please take note that:

- > No guarantee can be given that a visa will be issued.
- > All documents must be in English or a Swiss official language.
- > Only complete applications will be accepted.
- Families traveling together should note that <u>each family member</u> is required to submit all of the above mentioned documents together with his or her application.
- Family members (spouse, child or dependent ascendant) of Swiss, EU-EEA citizens are exempted from payment of the visa fee and from purchase of a travel health insurance. However, proof of the family relationship is required (marriage certificate/birth certificate). Spouses of **Swiss** citizens may submit their visa applications without booking an appointment.
- > Additional documents or information may be requested by the Consulate General of Switzerland.
- Supporting documents from Mainland China (e.g. bank statements, proof of employment, travel insurance or itinerary etc.) may not be verified by the Consulate General of Switzerland in Hong Kong.
- There are no express visas available. Visa applicants are advised to submit their application at least 15 days prior to departure. Processing your application usually takes 2 working days but might take up to 2 weeks for certain nationalities.
- A non-refundable visa fee has to be paid in cash when submitting your application. We also accept credit cards (Visa/MasterCard) but <u>no</u> cheque payments.
