

Short Term Schengen Visa Requirements

Please note: To apply for a visa, you need to be a resident of Cyprus. If you are not a holder of a Cypriot Residence Permit, you will have to apply for a Swiss visa in your country of residence.

The applicant must appear in person to submit a visa request during the opening hours of the Regional Consular Centre in Athens.

Apply with the Regional Consular Centre in Athens

In order to apply for a visa at the Regional Consular Centre, it is necessary to appear in person. The opening hours for spouses of EU nationals are: Monday to Friday 10.00am – 12.00 noon (except Greek and Swiss public holidays) without prior appointment.

For the following nationals the visa processing time takes up to 14 working days:

Afghanistan, Algeria, Bangladesh, Belarus (applies only to holders of diplomatic and service passports), D.R. Congo, Egypt (does not apply to holders of diplomatic and service passports), Eritrea, Iran, Iraq, Jordan, North Korea, Lebanon, Libya, Mali, Mauritania, Morocco, Niger, Nigeria, Pakistan, Russian Federation (applies only to holders of service passports), Rwanda, Saudi Arabia, Somalia, South Sudan, Sri Lanka, Sudan, Syria, Tunisia, Uzbekistan (does not apply to holders of diplomatic passports or soldiers and police officers who travel for the purpose of exercising their duty), Vietnam, Yemen, Palestinians, Refugees, Stateless Persons.

Each case is reviewed separately at the time of application, and no guarantee can be given that a visa will be issued. NOTE: the Regional Consular Centre in Athens cannot be held responsible for any delay or if the visa is refused.

Please note that the visa application must be submitted to the Swiss Representation responsible for your place of residence.

It is suggested that you apply at least one month prior to departure, but not more than three months before the planned entry.

Non-compliance with the set guidelines (items not presented/photocopies missing) will lead to the application being rejected without being processed.
