| Project objectives | The overall objective is to increase the capacities within the GoG to reduce the country's disaster risks and to align the activities of the international stakeholders with the national DRR priorities. In the frame of this project, SDC provides expertise by funding a senior DRR advisor at UNDP Georgia. The DRR advisor supports the national partners, particularly the EMD, by providing technical assistance and policy advice, to adopt and implement relevant policies at the national and regional level. The project aims the following two outcomes: a) DRR as an established topic on the political agenda and relevant institutions are capable to fulfil their DRR mandate in Georgia. b) Integration of DRR standards in development projects to increase the sustainability. |
| Background | Georgia is exposed to a wide range of natural and man-made disasters, including earthquakes, floods, droughts, landslides, avalanches and tech- |

| | nological disasters. Combined with the country's vulnerability, due to the fragile economical and political situation, improper natural resources management and poor infrastructure maintenance this implies high risks and severe impacts in case a disaster strikes. Despite having signed the international DRR framework (Hyogo Frame- work of Action/ HFA), Georgia's disaster risk management system shows fundamental gaps. In 2005 a UN Disaster Assessment and Coordination (UNDAC) mission disclosed limited institutional capacities in disaster management (prevention/mitigation, preparedness/ response) at the central as well as at the local level due to a lack of human, financial and material resources. Thereafter the legal framework was revised and a law on "Protecting Population and Territory from natural and man-made Emergency Situations by the GoG, 2007" was adopted, tasking the EMD to elaborate a National Emergency Response Plan (NERP). Additionally to the NERP relevant action plans and complementary DRR projects need to be adopted in order to improve the country's overall disaster risk management in alignment with the HFA. Through past DRR projects SDC supported Georgia's disaster manage- ment system at the central level, by setting up the rescue base / training centre in Tbilisi, and at the local level by supporting the municipal au- thorities of Tsageri through various prevention and response activities. |

| Expected results (outputs) | a) Promotion of DRR at the national agenda and coordination: The GoG has adopted relevant DRR policies. UNCT has set up a coordination and information shearing mechanism with national and international stakeholders. b) DRR mainstreaming and capacity building: UN's and other international stakeholders' activities are in line with DRR standards. |
