 Customs system, other import duties, special accompanying documents (sources)

The Customs system in Ghana along with other revenue mobilisation agencies is integrated into the Ghana Revenue Authority (GRA). The Customs Division is responsible for collection of Import Duty, Import VAT, Export Duty, Petroleum Tax, Import Excise and other taxes. It is a requirement to obtain environmental permits from the Environmental Protection Agency (EPA) before commencement of construction and operations of large scale and significantly impacting undertakings as well as for small and medium activities.
