PUBLIC SAFETY AND SECURITY PROGRAMME - INTERNAL AFFAIRS COMPONENTS:

This component aims at ensuring a proper access of citizens to law enforcement services by applying the community policing concept. This approach will be led by the General Inspectorate of the Romanian Police, acting as Programme Component Operator, in partnership with the School of Police Agents “Nicolae Golescu” in Slatina and the Psychosociology Center within the Ministry of Interior. Swiss support will be provided by the NGO Coginta and the SAVATAN Police Academy.

With the aim to enhance the contribution of the police to the daily safety of the Romanian population, this component focuses on reinforcing the fight against the trafficking in human beings and organized crime. Under the direct responsibility of the General Inspectorate of the Romanian Police, this approach has the National Agency against Human Trafficking, the Canine Center “Dr. Aurel Greblea” in Sibiu as well as the International Organisation of Migration (IOM) as partners. The Swiss Federal Office of the Police (FEDPOL) and the Basel Institute on Governance will support this initiative.

The third approach aims at enhancing the support for the population in emergency situations, through better intervention of the SMURD (*Mobile Emergency Resuscitation and Extrication Service*) Air Rescue and the development of a voluntary culture in civil protection. Led by the Emergency Situations Department, the component is additionally supported by the General Inspectorate of Aviation and the General Inspectorate of Emergency Situations, as Romanian partners, together with the REGA, as Swiss partner.
