

## Checklist for Official visit for Diplomatic/Official Passport Holders and Members of official Delegations

To International organizations in Switzerland (i.e. UN, WHO), the Netherlands (i.e. International Court) and Belgium (i.e. NATO)

Schedule your appointment at least 3 weeks prior to your planned departure date in order to allow sufficient time for the processing of your applications. Appointments are scheduled, confirmed and cancelled by calling the **Visa Section of the Embassy of Switzerland**

- o Fill all parts of the application form **and** the questionnaire in clear writing or typing.
- o Arrange photocopies of all the supporting documents as per the checklist order.
- Keep all the originals of the supporting documents separately.
   Original documents have to be shown at the VFS counter but will be returned to the applicant after the interview.
- All the photocopies of the documents should be in A4 size.
   These photocopies are part of the application and will not be returned to the applicant.
- Do not staple the documents together.
- Documents in Sinhalese, Tamil or Dhivehi must be presented with an official translation in one of the following languages: English, German, French or Italian.

| 5. | For individuals: Verbal Note from Ministry of External Affairs or the respective Embassy, invitation letter from International Organization mentioning the full names of the official travellers, the purpose, name of organisation to visit and duration of stay.  |           |   |     |

| 6. | Ordinary passport holders: Have to be mentioned in the Verbal Note of the Ministry of External Affairs, additionally a letter from the organization/employer in Sri Lanka or Maldives indicating:  - Name of the travelling employee  - Date of appointment & profession   |  |  |

| 7. | <b>Confirmation letter from the host institution</b> in Switzerland, the Netherlands or Belgium. If several entries are needed, this has to be clearly explained in the invitation letter of the host institution.   |  |  |
| 8. | Travel health insurance (only for ordinary passport holders). The insurance has to cover the entire period of stay in the Schengen area. Medical and hospital coverage must be USD 50'000 (Euro 30'000) and has to include repatriation in case of emergency or for medical reason. Credit Card insurances are not accepted. |  |  |
| 9. | <b>Diplomatic or Official Passport holders on a private trip</b> must submit payslips for the last 3 months & Proof of ETF/ EPF or Maldivian social insurance contribution.  |  |  |

#### Visa processing fee for Switzerland:

For Diplomatic and official passport holders: free of charge

For Ordinary passport holders if sponsor is an International Organization with Headquarters Agreement in Switzerland: free of charge

## Visa processing fee for the Netherlands and Belgium:

For Diplomatic and official passport holders: free of charge

For Ordinary passport holders if sponsor is an International Organization with Headquarters Agreement in the Netherlands and Belgium: fee of Euro 80.00

Please prepare the exact amount in Sri Lankan Rupees, which has to be paid at the time of lodging the application. For the amount in Sri Lanka Rupees, refer to VFS website, frequently asked questions

In case of application finally being refused or withdrawn the fee is not reimbursed.

- to send the application to the Swiss Federal Authority for decision.
