

## Visa for business

Please note: only foreign residents and foreign students in the United States who have a valid permanent resident card or U.S. visa (e.g. categories F1 (I-20), H1B (I-797), G1, J1, I-512 etc.) may apply for a visa. If you have a B1 and/or B2 visa, you must apply in your country of residence.

**Note for children and spouses of Swiss and EU/EFTA nationals:** points 7, 8, 9, 10, 11 and 13 do not apply. Instead, please include the following documents: Notarized copy of valid Swiss or EU passport of spouse/partner/parent and proof of family relation (marriage/birth certificate or partnership contract).

## Requirements:

- 1. Printed Schengen visa application form, fully completed and signed by the applicant. Please fill in and **print** your online application as well as **book your appointment** (if <u>personal appearance</u> is required) on the website: <u>www.swiss-visa.ch</u>.
- Two recent identical passport photos: please consult the requirements on the <u>webpage</u>.
   US-standard size passport photos will also be accepted. Digital files and photocopies will **not** be accepted.
- 3. Original valid passport or travel document. Must be valid for at least three months beyond the planned stay, issued within the previous ten years and have at least 2 blank visa pages opposite each other.
- 4. Copy of valid passport or travel document (photo, data and signature pages only)
- 5. Notarized copy of proof of residency in the USA, e.g. a valid permanent resident card (green card), H1B visa (plus I-797), F-1 visa (plus I-20), etc.
- 6. If applicable, copies of previous Schengen visas issued within the past 5 years
- 7. A copy of your flight reservation.
- 8. Letter of invitation from the host company in Switzerland indicating your full name as well as the dates, duration and purpose of your planned business trip(s).
- 9. A recent letter from your employer in the US, including your position and salary, and stating that they guarantee for your expenses during the stay in the Schengen space. If you are self-employed, please include a copy of your business license, tax return and bank statement.
- 10. If requested, a valid visa in your travel document for the country you are visiting after leaving the Schengen space.
- 11. A letter from your insurance company confirming international coverage of at least USD 40,000 including:
  - emergency medical expenses
  - emergency hospital treatment
  - repatriation for medical reasons
  - repatriation of mortal remains

If you do not have insurance, or your insurance company cannot provide such a specific letter, you must purchase insurance for the entire duration of your trip and provide proof of purchase.

- 12. Passports with issued visas will be mailed back. Please provide a prepaid, self-addressed return envelope with a tracking number of a secure carrier. Families/couples should send in only one return envelope. <u>Applicants</u> must indicate their <u>name and address both as sender and recipient</u>. The Swiss representation does not assume any liability for the loss of documents submitted or returned by mail.
- 13. The visa fee is subject to change: please check the website for the current fee.
